### Vendor Guidelines

This event is held in the Richfield Nature/Historic Park, a sensational wooded backdrop with many historic buildings including the renovated Messer/Mayer Grist Mill. This is the 17<sup>th</sup> year for this event.

#### Vendor Amenities:

- Easy access for setup
- Sufficient space between booths
- Free coffee and pastries during setup
- Booth reliever (typically mid-day)
- Fliers for advertising

#### Guidelines and Requirements:

- **Application Fees and Deadlines**
  - Booth Fee for applications received before or on April 1, 2025 -- \$60
  - Booth Fee for applications received from April 2, 2025 through June 1, 2025 -- \$70
  - Review Fee (nonrefundable): \$10 (Review Fee is waived for previous exhibitors at this event)
  - No applications will be accepted after June 1, 2025
  - There are limited spaces for vendors
- **Booth Information:**
  - Vendors supply their own booth/tent (10 ft x 10 ft), tables and chairs – the fair goes on rain or shine
  - Due to limited volunteers, we are unable to provide help with setup/take down of booths
  - **Setup must be completed by 10 am and remain in place until 4 pm**
    - **When setting up, be sure to unload your booth and supplies. Then, immediately move your vehicle to the parking area before setting up. This will alleviate congestion and blocked vehicles.**
    - **At 4 pm, vehicles can be moved from the parking area to your booth. This must not be done prior to the 4 pm closing time. Take down must not be started prior to 4 pm.**
- **Product Requirements:**
  - Vendor products would be food and other consumables. Examples: fudge, nuts, jam/jelly, bread, butter, homemade pet treats, personal care (non-commercial), etc.
  - Personal care products are considered in the vendor category unless there is some artistic enhancement such as carving, sculpting, painting
  - Vendors will not be accepted if it is felt that their product could be in competition with exhibiting artists
  - This event will have 1 or more main food vendors. The main food vendor(s) has/have their own set of guidelines
- **General Information**
  - All of the above requirements will be strictly enforced
  - FYI – Sales Tax for Washington County is 5.5%
  - If necessary, make sure you have the required insurance/license to sell your products
  - Any vendor under the age of 18 must be accompanied by an adult
  - No political activities are allowed as RHS is a 501(c)(3) organization.

## Vendor Application Process

---

### Follow These Steps:

1. **Mail Application Form plus \$10 Review Fee (Review Fee is waived for returning vendors) and applicable Booth Fee based on application date\*. Separate checks for Review Fee and Booth Fee. Booth Fee will be returned if your product is not accepted. Both Booth and Review Fees will be returned if all vendor spaces are filled.**

**\*Booth Fees:** Now through April 1, 2023 -- \$60; April 2, 2025 through June 1, 2025 -- \$70

2. **Mail 2 photos:** 1 photo showing your product and 1 photo of your booth. Returning vendors need not submit photos unless there is a change in your product.

***Note: Please include a self-addressed envelope with sufficient postage attached if you wish the photos to be returned.***

## Cancellation Policy

---

If you have to cancel:

- Before April 1, 2025, the full amount of the booth fee will be refunded.
- Between April 1, 2025, and May 15, 2025, half of the booth fee will be refunded.
- After May 15, 2025, booth fee will not be refunded (no exceptions.)
